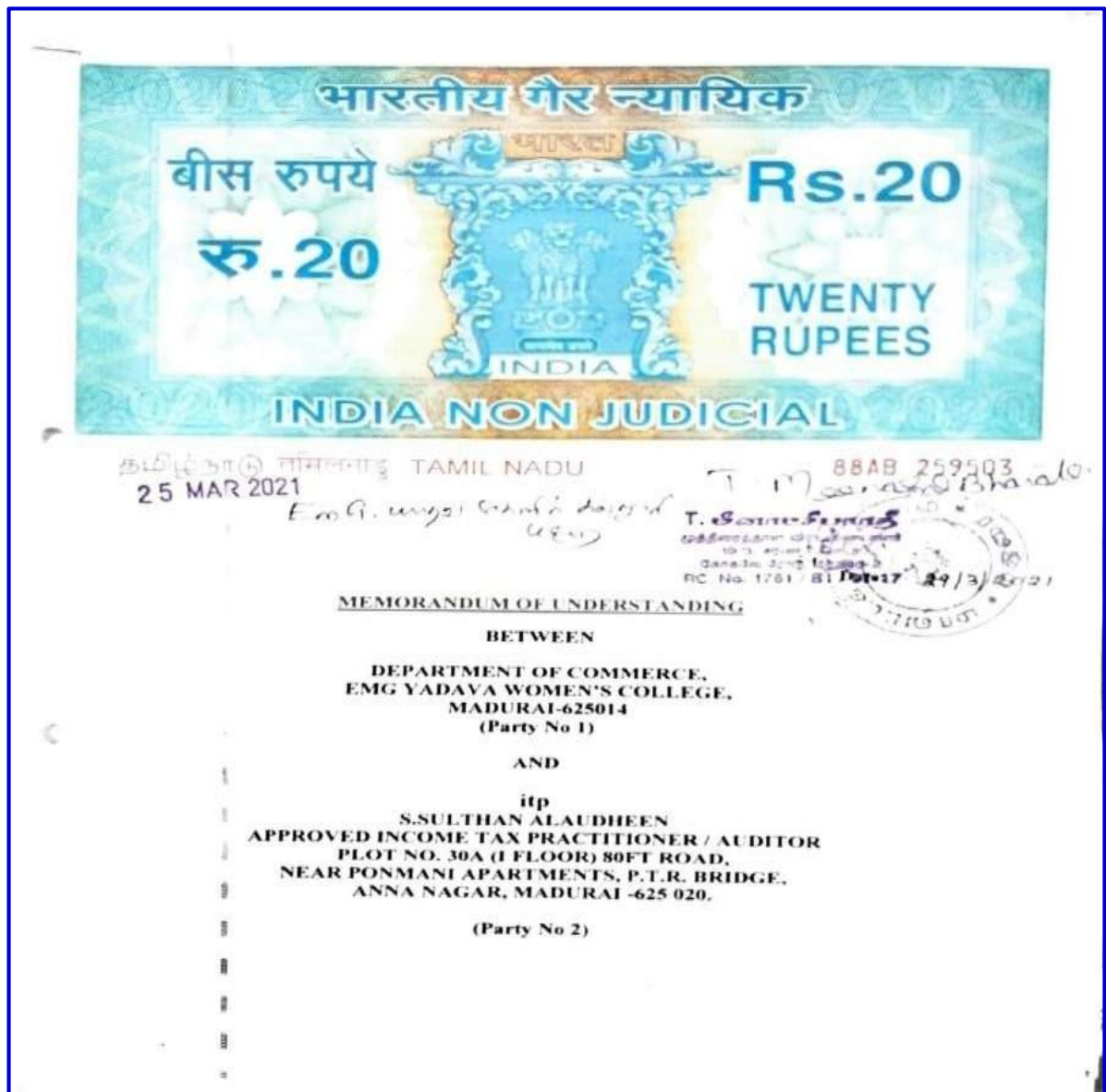
Report:
